## **TEACHING:**

I have taught a range of courses and seminars on Islamic history (from Pre-Islamic Arabia to contemporary times), Shia Islam, Fatimid history and thought, classical texts, Sufism, Elementary Arabic at University of Edinburgh, at undergraduate and graduate levels, for over 20 years (1989-2009).

At the Institute of Ismaili Studies (IIS), I have designed and taught a range of courses related to the above themes for the graduate programmes in humanities and Islamic studies as well as for the Secondary Teacher Educator Programme GPISH since 1999 to date. I also teach on the various adult education programmes at the IIS.

Most recently, I developed an FHEQ Level 7 term-long graduate course titled *Prophet Muhamad and Imam Ali in the discourses of Muslim Communities*, for which I serve as the Module leader and lecturer. On average, I teach 100+ hours per year.

I have been involved with the International Baccalaureate programme since 1998 and was their Chief Examiner for Islamic History from 2001 to 2008.

## **WORK EXPERIENCE:**

The Institute of Ismaili Studies: I joined the Institute of Ismaili Studies in 1999 as a Research Associate and Academic Counsellor for the graduate students. I was also assigned the responsibility of coordinating the teaching of Arabic on its graduate programme.

I served as the *Coordinator of the Quranic Studies Unit* (2001-2004). As the founding coordinator, I was involved in the shaping of the Quranic Studies Strategy and in initiating the multivolume Anthology of Tafsir Literature. I also oversaw the first publication of the unit titled, Modern Muslim Intellectuals and the Quran, ed. Suha Taji Farouki, 2004 and the conference titled Word of God, Art of Man which was part of the commemoration of the Institute's 25<sup>th</sup> anniversary celebrations.

I then served as the *Head of the Department of Community Relations* (2005 – April 2012). In this role, I provided oversight to three main areas work: Commissioning and dissemination of community related research; development and delivery of training and orientation for community leadership and educators, and development and dissemination of educational resources that are of particular interest and purpose for the community educators and the leadership.

Since 2012 to date, I serve as the *Head of Constituency Studies Unit*, which is responsible for undertaking research and developing educational resources on key issues that impact Ismaili communities and those amongst whom they live across various regional geographies and cultural spheres.

I am also the founding editor for the *World of Islam* series, through which the IIS seeks to broaden its scholarly reach to a wider and more diverse readership. To date, three titles have been published in the series, in text, audio and e-book formats. The books have been translated in various languages: Gujarati, Persian, Portuguese, Russian and Urdu.

I also serve as the series editor for the *Living Ismaili Traditions* series, a bespoke series developed for the Ismaili community to inform and inspire them regarding the community's diverse

My involvement with the *International Baccalaureate Programme* began in 1998 when I became an Assistant Chief Examiner for their diploma level course on Islamic History. In 2002, I became their Chief Examiner for Islamic History and served in that role until 2009. In that capacity I was actively involved in the integration of Islamic History within the broader curriculum on history, where it now resides. I continue to remain connected to the organisation as their consultant on Islamic history.

I have also served as an Associate Assessor for Muslim schools in Scotland with *Her Majesty's Inspectorate for Education* from 2005 to 2009.

Since 2012 to date, I serve as a member of the *Board of Governors at Edinburgh Napier University*.

## **VOLUNTARY WORK:**
